

- 3. In a bucket: add 2.2 lb of 540/H coving paste.
- 4. Add hardener powder 50W as stated in the table above for installation temperature. Mix thoroughly for at least 1 minute with a high-speed drill.
- 5. Add 4.4 6.6 lbs coloured quartz 10-40 mesh, mix thoroughly.
- Immediately apply to floor/cove edge using specialist-coving tool, do not work from the bucket, empty entire material along cove edge. The coving mix must be compacted well.
- 7. Do not allow SOLVENT to come into direct contact with Plastifloor® coving mix, always wipe down tools prior to reapplying to cove. Allow to fully cure.
- 8. Apply seal coat to match floor finish.
